***Subject;- Appointment to the post of Chairman and the Member Secretary,
Goa State Pollution Control Board.***

Applications are invited from interested and eligible candidates for appointment to the posts of the Chairman and the Member Secretary, Goa State Pollution Control Board (GSPCB), Goa.

2. The GSPCB was established under provisions of the Water (Prevention and Control of Pollution) Act, 1974. The GSPCB exercises functions related to prevention and control of pollution. The Chairman and the Member Secretary shall be a full-time incumbent.

3. The following are the terms and conditions for the post of the Chairman and the Member Secretary, GSPCB, Goa:-

	(b) Desirable	<p>1) should possess a doctoral degree in environmental management from a recognised University or institute and excellent record of peer reviewed research publications and experience of organising environment related training programmes for service personnel, shall be a considered as a desirable qualification.</p> <p>(2) An officer working under the Government or public sector undertaking or University or an autonomous body or statutory body possessing the requisite specified Eligibility, educational qualification, experience etc may be considered for nomination as the Chairman on deputation basis: Provided that the period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department shall ordinarily not exceed three years.</p> <p>3) Knowledge of Marathi</p>
5.	Age Limit	The age limit for nomination as Chairman shall be sixty-two years as on the last date for the receipt of applications.
